DIRECTIONS FOR USE

Apply ARRMASOAP 25 with a stiff brush and allow to stand for 5 minutes. Brush off dirt and other built up materials before rinsing thoroughly with water. Excess build-up of oil/grease, etc. may require a second application.

When used with Drumclean 100 or Concrete Blaster, follow the products usage instructions prior to applying ARRMASOAP 25.

ARRMASOAP 25 is a clear yellow liquid.

PRECAUTIONS/LIMITATIONS

- ARRMASOAP 25 is an alkaline liquid and should be handled accordingly to MSDS.
