PACKAGING

EUCOLITH 133 is packaged in bulk, 275 gal (1041 liter) totes, 55 gal (208 liter) drums and 5 gal (18.9 liter) pails.

DIRECTIONS FOR USE

EUCOLITH 133 is used at a rate of 12 to 20 oz per 100 lb (750-1250 ml per 100 kg) of cement.

EUCOLITH 133 should be added to the concrete batch just prior to or at the beginning of the water addition to the batch.

EUCOLITH 133 should be stored above 32°F (0°C).

PRECAUTIONS / LIMITATIONS

- Protect from freezing.
- If material has frozen, warm material to 70°F (21°C) and agitate for 6-8 hours.
